MEMBERSHIP

Application

A completed Application form shall be submitted by the student to allow Membership to be set up.

By applying, You undertake to Us that once a member You will abide by these Terms and Conditions and will notify Us of any changes to your educational status within 30 days. Failure to notify Us of any changes within 30 days may result in the cancellation of your Membership.

A Student undertaking a short course, of less than 3 months, is not eligible to apply for the NICEIC Student Membership.

Conditions for continued Membership

Membership will continue whilst You remain a Student undertaking relevant technical competency training.

Upon completion of your training your Student Membership will expire.

We may at any time request confirmation of your current Student status, Membership will expire should this not be provided upon request.

Cancellation of Membership

As a student member You are not authorised to use any NICEIC branded forms, logos or certificates for personal or business use.
